With your support PEF reached 6,600 middle school students with student advisories and celebrated 2,303 "50 Book Club" Readers. What a way to share PEF's 25<sup>th</sup> year!



Our student advisory program, Navigation 101, successfully moved from its pilot year [07-08] for 2,200 sixth graders to serving 6,600 6<sup>th</sup> thru 8<sup>th</sup> graders in all Paterson elementary schools. PEF provided student reflection materials and training for advisors and the Paterson Public Schools provided staff and other materials. "We are

delighted with the outcomes," said Mike Smith, Paterson Public Schools' new Director of Guidance. "Students have explored their interests, discovered their learning styles and explored careers. Best of all, they have shared their new knowledge about themselves with their parents through student led conferences."

PEF is supporting the program for a third year as Dr. Evans, Paterson's State District Superintendent, expands student advisories to the high schools as part of his strategic plan.

"50 Book Club" continues to grow with wonderful community support. "Every year we throw a Street Fair for the kids and their families. Each year more people step forward to help make the event exciting and special" says Karen Mayo-Hogan of PEF's Board.

This year's surprise guest was President Obama. Students were asked to sign a pledge to graduate from high school. Most heartening was the number of children who said, "I'm going to graduate from college!"

## Roche Summer Informal Science

Thanks to Roche and PEF, four Paterson middle school science teachers spent four weeks developing hands on science lessons on the subject of water. They asked the question, "Would you swim in the Passaic River?" The teachers were assisted by five rising college freshman from Paterson.

Working with children from the Paterson YMCA and Paterson's summer recreation day camps, they tested the lessons. Children, interns and teachers valued the experience. "Let's do it again next year," was the universal response. We hope that we can.

Our Roche project has an interesting background. The most veteran teacher on the team, Lynn Tarant, had been a PEF minigrant and Chase Active learner winner many times over. She and Sarah Sterling-Laldee were teacher leaders for the Living Classroom" program, sponsored by the Dodge Foundation, which was also the training ground for the five interns. Dodge had also provided Sterling-Laldee the opportunity to do field study with Earthwatch. Earthwatch provided her with the impetus to volunteer to create PEF's Girls United for the Earth and the girl's study trip to Grenada. Two of the interns are veterans of the Grenada trips.



"I'm so grateful," said Tarrant. "Roche gave us an opportunity to bring all our experience to bear. I now want to travel internationally to study and bring it back to Paterson's kids."

### Our campaign platform:

We are failing our kids with high stakes testing for graduation. Some young people are graduating without the necessary skills and others are held back because of unfairness in the testing system.

Before any additional graduation tests are implemented, the NJ Department of Education must certify that all students have access to the qualified teaching personnel and academic support necessary to prepare for them.

### We call for:

- \* Alternative assessment options: as the state moves towards new end of course and graduation exams it should allow districts to develop additional local performance assessment systems that support better teaching and learning and could be externally validated by the state.
- \* An implementation plan for all high school redesign initiatives to be given to schools before any new requirements are made. Such a plan would outline resource requirements, education requirements for teachers, and sample curricula. At the same time, there would be district assessment for "redesign readiness." The need for such a plan is outlined in A3692/S2574, the NJ secondary Education Redesign Review Act.
- \* An explicit urban secondary reform initiative within the state's high school redesign efforts. Parents

should be on all school-based committees about graduation and performance. Such committees are called for in the NJ School Funding and Reform Act regulations, (N.J.A.C. 6A:13e).


