Paterson Children Need Your Vote!

After 25 years of State control, we are finally making real progress toward returning Paterson Public Schools to local control. Paterson regained control of Operations, Fiscal and Personnel. There is an expectation that the remaining 2 areas, Instruction & Program and Governance will be returned over the next 2 years.

When the Board gains control of Governance, it will have full authority to decide who will be Superintendent. Since our current Superintendent is State appointed, it's likely that we will be searching for a new candidate. The School Board members we elect on November 8 will play a critical role in this process. You have a critical role also. Your vote will count in the selection of 4 members of this 9 member Board!

In addition to hiring and firing Superintendents, the school board has many other important roles. As elected community leaders, they must listen to the community's views and incorporate our needs into their decision-making. School board members must have a vision for our children's education and must be able to share that vision. They need to understand that their role is policy and oversight, not administrative. They must be willing to collaborate with their peers and the Superintendent to move the district forward. As the district faces the crisis of continued State underfunding and resulting budget cuts, they must absolutely put the needs of the children first!

The information in this guide will help you to make an informed vote. We encourage you to read it thoroughly and also to seek out additional information. PEF's Candidate Forum will be airing on the Paterson Education Access TV channel until Election Day. We will also post it on our Facebook page. Other community organizations will likely host candidates forums. Please take advantage of every opportunity to meet the candidates face to face. Ask some of the key questions listed on our website or make a list of your own.

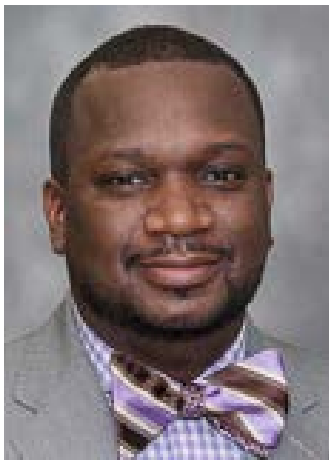

Three major issues:** (1) Flat funding: This is an issue which resonates rather deeply with me. The cost associated with instructional staffing alone represent approximately 70% of the district's operating budget. As funding remains flat, that number grows larger every year exposing the district to serious financial disaster if nothing changes. The fact is – if this trend is not reversed, sooner rather than later, our ability to provide some basic required services will be impacted severely. This must get fix and get fixed quickly. (2) Parental engagement: Research has shown that children perform at a higher level when parents are engaged in their social, emotional and educational development. Unfortunately, we are not seeing the kind of response from our parents to indicate to us that they do understand the danger they expose their children to when they are not engaged at that level. I consider this as a serious breach in our ability to move our educational system forward, and I'm committed to finding a way out of this quagmire. (3) Closing the Achievement Gap: This should be the primary purpose of all who seek to serve in this capacity. We have been experiencing a refreshing rebirth in recent times regarding improved outcomes. However, much more needs to be done to get us where we ought to be. I'm committed to getting needed technology in the hands of every child in the district.

Data indicates that students who are involved in the arts are more likely to perform better academically. One of my highlights working on the board during my first tenure was helping to bring the Paterson Music Project into Paterson Public Schools. (3) Recreation/After School Programming – our students do not have adequate access or resources or quality programming after the regular school day concludes. Wrap around services are desperately needed to ensure academic achievement as well as affording working parents the opportunity to have their children in a safe and productive environment while they are still at work.

☑ What the Board of Education Does

Under the Constitution of the State of New Jersey, the State is responsible for providing education for its citizens [the “thorough and efficient system of free, public schools” clause]. The State establishes local school boards and requires them to run the schools under its [the State’s] rules. The powers of the School Board are limited; it operates under a very comprehensive set of regulations known as NJ Administrative Code 6A. As a state-operated district, the Paterson School board is advisory and has no power over personnel. The School Board’s actions can be vetoed by the State Superintendent.

➔The School Board’s most important role is to hold the school system accountable for educating Paterson children.

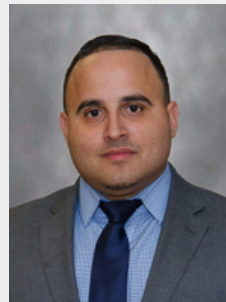

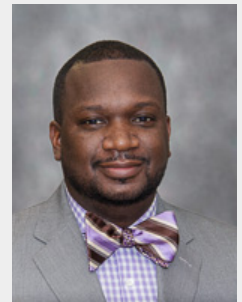

☑ The NJ School Board Oath of Office

Every member of the Board of Education takes the following oath of office:

“I do solemnly swear (or affirm) that I will support the Constitution of the United States and the Constitution of the State of New Jersey, and that I will bear true faith and allegiance to the same and to the Governments established in the United States and this State, under the authority of the people. So help me God.

I do solemnly swear (or affirm) that I possess the qualifications prescribed by law for the office of member of a board of education and that I will faithfully, impartially and justly perform all the duties of that office according to the best of my ability So help me God.”

While school board members are elected by local citizens, they are responsible to the State of New Jersey. Under the New Jersey Constitution, they are responsible for providing a “thorough and efficient” education. Our State Supreme Court has interpreted that to mean an education that makes them competitive in the market place and able to be good citizens.
